**If the treating WC physician refers you to a Specialist Physician, or places you out of work, or recommends surgery please do the following without delay:**

(1) Referral—**Call Company Nurse (1-888-770-0925) immediately** to obtain authorization for your visit.

(2) Placement out of work or for surgery--**Please notify your Building Administrator and Vera Fox in HR.** Be sure to fax all medical notes to the Office of Human Resources to (540) 834-2551.

(3) Prompt Reporting--Timing is essential regarding workplace injuries; therefore, do not delay in addressing the above mentioned steps. Proper time management aids in a stress-free process for medical treatment, surgery, classroom coverage, and dissemination of Loss Wage Benefits (based on eligibility).

**Very Important Messages:**

**Opting for Outside Treatment-- If you opt to seek medical treatment outside of the Panel of Physicians for our school division, all medical bills and services relating to this injury are your responsibility. Selecting this option jeopardizes your Workers' Compensation benefits.**

**Hospitalization Due to Injury--Hospitalization:--If you are hospitalized due your workplace injury, please contact your Building Administrator or Supervisor immediately and call the Office of Human Resources (540) 834-2500, ext. 0 or 1500.**
