

**POST OAK MIDDLE SCHOOL / SPOTSYLVANIA HIGH SCHOOL
2018-2019 ACTIVITY BUS PILOT**

Beginning August 13, 2018, Activity Buses will operate from Post Oak Middle School and Spotsylvania High School on Monday through Thursday evenings for after school activities. It is the responsibility of the student and his or her parent/guardian to identify which activity bus stop to use and to have arrangements in place for transportation home from the drop-off location. The activity buses will leave Post Oak Middle School promptly at 5:15 PM and Spotsylvania High School promptly at 5:30 PM. Activity buses are available for any Post Oak Middle School and Spotsylvania High School student who participates in an organized and supervised sponsored activity that requires the student's attendance beyond the regular instructional day. It is the responsibility of the student to be ready and waiting in the assigned pick-up area at the designated departure time. Riding the activity bus is a privilege and will be available only to those students who abide by the rules established by the Spotsylvania County Public Schools Code of Student Conduct and Post Oak Middle School, Spotsylvania High School and the Department of Transportation. Buses will not operate on early dismissal days, inclement weather days, or days on which after-school activities are cancelled.

BEHAVIOR AND ACCOUNTABILITY:

1. The school division has the right to revoke the privilege of the student to use the Activity Bus in the event of inappropriate behavior. The consequences for misconduct may also include suspension from the sponsored activity in which the student participates and other disciplinary action under the Code of Student Conduct
2. Students may only bring equipment/projects on the bus that they can manage within their individual seating space.
3. Cleats/spikes, clean or dirty, are not permitted to be worn on Spotsylvania County buses.
4. The student is financially responsible for any damage he or she has caused, intentionally or unintentionally, while riding the activity bus.
5. If a student has to be returned to the school more than two times due to no one being present to receive him or her at the designated drop point, the student will be subject to losing the riding privilege.
